FLYING JUST OFFSHORE OF AN OCEAN OR OVER A WATERSHED IN A SMALL PLANE ILLUMINATES THE INTERPLAY BETWEEN WHAT HAPPENS ON LAND AND HOW THAT AFFECTS THE AQUATIC ENVIRONMENT. OVER THE YEARS, LIGHTHAWK HAS FLOWN HUNDREDS OF HOURS TO SUPPORT ESTABLISHING MARINE PROTECTED AREAS (MPAS) ALONG THE COAST OF CALIFORNIA AS PART OF A PROCESS MANDATED BY CALIFORNIA'S LEGISLATURE.
